ACA accomplishes this by devoting a substantial part of its resources to issues that affect public policy and legislation, by seeking parity in reimbursement of its members from insurance companies and improving the quality of patient treatment and by carrying out a dynamic strategic plan to help ensure the professional growth and success of doctors of chiropractic. Fundraising costs associated with raising funds for the legal action fund and CHAMP are included in this category.

Membership Services & Products - ACA devotes a significant portion of its resources to serving its existing members. The costs of retaining members are included in this program.
